I, _____ (please print full name), hereby request and consent to receive **Harmonyum** treatments and other procedures within the "Code of Ethics and Practice" of **Harmonyum** on me (or on the patient named below, for whom I am legally responsible) by the Harmonyum Practitioner/Bio-Metaphysical Therapist named below-and/or other certified Harmonyum Practitioners/Bio-Metaphysical Therapists who now or in the future treat me while employed by, working or associated with, or serving as back-up for the Harmonyum Practitioner/Bio-Metaphysical Therapist named below- including those working at the clinic or office listed below or any other office or clinic, whether signatories to this form or not.

While **Harmonyum** treatments are safe and pose no real physical risks, I understand that results are not guaranteed.

I understand that all of my records will be kept confidential and will not be released without my written consent with the exception of a necessary review by the clinical and administrative staff, and the Universal Force International Harmonyum Association.

I understand that I should not receive more than one **Harmonyum** treatment within a twenty-four hour period.

I understand that in no way does **Harmonyum** take the place of advice from my Medical Doctor or any other health care provider.

I understand that a complete treatment series includes seven **Harmonyum** sessions.

I understand that a normal and healthy component of any healing system, including **Harmonyum**, that seeks to support the body's internal healing mechanisms, is the phenomena of a healing crisis. A healing crisis is a normal occurrence, and can be associated with any medical system.

I understand that a Harmonyum Practitioner/Bio-Metaphysical Therapist must be neutral when giving a treatment. Neutrality means that he/she is not giving direct advice or judgment regarding their client's specific life situation or health matter. The Harmonyum Practitioner/Bio-Metaphysical Therapist supports the client in their journey toward self realization and consciousness by providing them with the spiritual tools of **Harmonyum**, meditation, mantra, mudra, breath work, and other modalities taught in the **Harmonyum** course work.

I understand that **Harmonyum** Therapy does not include the use of channeling spirits, acting as a Medium, acting as a Psychologist (unless Practitioner holds a license), or a Medical Doctor (unless Practitioner holds a license).

I, my heirs or legal representatives, in consideration of my **Harmonyum** Treatments forever release, waive, and covenant not to sue Harmonyum Practitioner/Bio-Metaphysical Therapist, the Universal Force Healing Center, Rootlight, The International Association of Harmonyum, its officers, employees, and any other people officially connected, for any injury and do release from any and all liability due to sickness, from whatever source which might occur during or after receiving a **Harmonyum** Treatment.
